<input type="checkbox"/> <a href="#">EXPORT DECLARATION</a>	<ul style="list-style-type: none"> <li>If the shipper creates the export declaration independently, provide the MRN number of the export declaration (EAD) – to be inserted in the transport order – and handover the export accompanying document to the driver</li> </ul>	
<input type="checkbox"/> <a href="#">COMMERCIAL INVOICE</a>	<ul style="list-style-type: none"> <li>Provide electronic copy of the commercial invoice</li> <li>Customs duties and valued added tax are calculated based on the value of goods and currency</li> </ul>	
<input type="checkbox"/> <a href="#">CUSTOMS TARIFF NUMBER OF GOODS (HS CODES)</a>	<ul style="list-style-type: none"> <li>Harmonised classification code of the goods</li> </ul>	<a href="#">List of customs tariff number of goods (HS Codes)</a>
<input type="checkbox"/> <a href="#">DESCRIPTION OF GOODS</a>	<ul style="list-style-type: none"> <li>In local language allowing correct HS classification</li> <li>Gross/net weight and number/type of packaging</li> </ul>	
<input type="checkbox"/> <a href="#">VALUE OF GOODS</a>	<ul style="list-style-type: none"> <li>Value of goods and currency to calculate the customs duties and value added tax</li> </ul>	
<input type="checkbox"/> <a href="#">INCOTERMS</a>	<ul style="list-style-type: none"> <li>Agree on delivery terms with your business partners, as they define who is responsible for the customs clearance and associated costs</li> </ul>	
<input type="checkbox"/> <a href="#">UK IMPORT PROCEDURE: FULL DECLARATION OR CFSP EASEMENT</a>	<ul style="list-style-type: none"> <li>Border Operating Model outlines UK import options, which need to be confirmed and initiated prior to the EU export</li> <li>Inform us which option will be used: the full import declaration (entry number 'ENO' of import declaration is required to enter the UK) or the CFSP easement (EORI of importer suffices to enter the UK)</li> <li>If we are not commissioned to prepare the full import declaration, provide the ENO in the transport order</li> </ul>	<a href="#">UK Border Operating Model</a>
